# Residents show their support for proposed cannabis store on Cambridge Street

#### By Cary Shuman

Residents attended an Aug. 8 public meeting, the first step in the application process for Jack Kelly who is proposing to open a cannabis shop at 31 Cambridge St., Charlestown.

Patrick Sweeney, the attorney representing Jack Kelly in the matter, said in his opening remarks that the process for the original proposal began in December, 2019, and the matter had traveled through the Zoning Board of Appeals, the Boston Cannabis Board, and the state Cannabis Control Commission.

"There was a bit of a falling out between the people involved. Other people dropped out, and Jack has picked it up and continues to go forward," said Sweeney.

Sweeney said the hours of operation for the store would be Sunday through Tuesday (10 a.m.-9:30 p.m.), and Wednesday through Saturday (10 a.m. to 11 p.m.). Following Sweeney's well-articulated presentation, residents expressed strong support for Kelly's bid to open the cannabis store. One resident commended Kelly's perseverance through what has been a five-year journey to open the store.

"I think the location is going to be fantastic and the store is going to be a tremendous asset," said a resident. "I'm excited and I sup-

# Coletta Zapata holds ZBA appointees accountable during council hearing

On Monday, Boston City Councilor Gabriela Coletta Zapata utilized what is normally considered a perfunctory city council committee hearing to hold Zoning Board of Appeals (ZBA) appointees accountable to enforce new East Boston zoning. The Planning, Development, and Transportation committee hearing was chaired by Councilor Sharon Durkan (District 8) and discussed various appointments to city boards and commissions. Councilor Coletta Zapata highlighted several issues related to ZBA decisions including non-compliance to Plan: East Boston, loosened standards for developers in granting "hardships" for variances, and the absence of a full-time representative from East Boston given the disproportionate amount granted in the neighborhood.

Additionally, she expressed shock and disappointment that ZBA members were not provided an in-depth briefing on new zoning reforms in East Boston to make informed decisions on existing cases. Plan: East Boston was approved by the BPDA board and subsequently the Zoning Commission in early spring 2024. She urged the administration and the Inspectional Services Department, which holds administrative oversight over the ZBA, to immediately rectify the situation through formal training or policy bulletins. "PLAN: East Boston is the culmination of five years working in

# AN OLYMPICS TO REMEMBER

From the glorious opening ceremonies along the Seine River more than two weeks ago to Sunday's closing and traditional pass-off of the Olympic flag to Los Angeles, the site of the 2028 Summer Olympics, the Paris Olympics were spectacular in every respect.

The performances by the athletes featured both incredible, come-from-behind, down-to-the-wire finishes (such as Noah Lyles in the 100 dash and Cole Hocker in the 1500) and dominating efforts (such as Katie Ledecky in the distance swims and Sydney McLaughlin-Levrone in the 400 hurdles) that created Olympic moments that will last a lifetime for American fans.

The exhilarating victories in the final weekend by the women's soccer team and the men's and women's basketball teams placed an exclamation point on the games for Team USA, which far outdistanced the field in the medal count.

As usual, the games provided a respite from the trials and tribulations of the world and offered a glimmer of hope that the spirit of the games, in which athletes from nations across the globe can come together to compete with honor and sportsmanship, might transcend the forces of evil that bring so much suffering to our world.

For our part, the Olympics always had been a shared experience with our family and friends when we were younger, and then with our own children. But our Olympics these days are a solo event, though we immediately send texts to our kids and their significant others when something big happens.

We don't mean to sound maudlin, but it made us realize that though we now have many new Olympic memories, we're at an age where we wonder how many more we'll have in the future. (And we'll just leave it at that).

On the other hand, we can't wait until Los Angeles, 2028!

### WOMEN ARE MAKING AMERICA GREAT

So here are some interesting facts from the Paris Olympics: Women accounted for more than 50 percent of the medals won by Team USA and two-thirds of our gold medals. If the US women were a separate country, American women would have ranked second in the world in the medal count, behind only China.

Those statistics struck a chord for us in the context of the controversial comments made by Republican vice-presidential candidate JD Vance in which he essentially blames women for not having enough children to maintain our population at a stable rate. (We should point out here that America's population is growing thanks to the recent influx of immigrants, who thankfully are doing all of the labor-intensive jobs that American citizens either don't want to do or are too old to do.

Vance's now-infamous quote offering his view of women in leadership positions in our country -- "a bunch of childless cat ladies who are miserable at their own lives and the choices that they've made and so they want to make the rest of the country miserable, too" -- and his other comments, in which he proposes incentivizing women, via the tax code and voting rights, to have more children, make it clear that Vance and the MAGA movement believe women should be barefoot, pregnant, and in the kitchen.

The Supreme Court's reversal of Roe v. Wade two years ago and the suggestion by some (such as Justice Clarence Thomas) that the court's birth control decisions from more than 50 years ago also should be overturned to allow for regulation by the states highlight the extent to which the MAGA crowd wants to control women. Even more telling, the controversial Project 2025 document that was put forward by prominent Republican groups proposes eliminating child support and alimony so as to discourage divorces, further demonstrating that the MAGA movement seeks to return women to an era of subjugation to their husbands, even in abusive relationships.

But we have news for these folks: Beyond our women's achievements at the Olympics, America is great in every respect thanks to our women, who now make up about 60 percent of college graduates and who constitute a majority of law school and medical school students in our country. Without the contributions of women in the U.S. workforce, our economy, which is the strongest, most-dynamic economy in the world, would be a shell of what it is today.

We also would suggest to JD Vance and others of his ilk that the real blame for the decline in our birth rate lies primarily with American men, who alltoo-often are lazy and lacking in ambition, and who engage in risky, juvenile behavior that makes them unattractive as spouses and potential fathers.

The bottom line is simply this: American women, from the Olympics to all aspects of our society, are making America the greatest nation on earth today.

ABCD is excited to announce that it has been awarded nearly \$700,000 from the Healey-Driscoll Administration's Emergenging Adult Reentry Initiative to expand and support its BRIDGES Returning Citizens Center (BRCC) -- a specialized career center which offers employment and training services to individuals ages 18-25 who are returning from incarceration. As a grant recipient, ABCD will deliver promising and evidence-based programming to help young adults avoid future contact with the criminal justice system by placing clients who need jobs in industries that are greatly in need of qualified workers. According to the Organization for Economic Cooperation and Development, there were approximately 8.8 million vacancies in the United States during July 2023. While this number decreased, the Bureau of Labor Statistics reported that more than 200,000 positions were unfilled in Massachusetts. Launched in 2023, the BRCC is located within the ABCD-operated MassHire Metro North Career Centers.

"We are thankful to the Healey-Driscoll Administration for their generous support of our BRIDG-ES Returning Citizens Center located within the ABCD-operated MassHire Metro North Career Centers," said ABCD President and CEO Sharon Scott-Chandler. "Workforce development is a key aspect of ABCD's low-income programming and services, and is beneficial to both workers and employers in Greater Boston, specifically in the 18-25 demographic." Scott-Chandler noted that while young people are more at risk for recidivism because of limited skill sets, studies by the National Institute of Justice show that steady employment is a key ingredient for reducing recidivism. "ABCD's BRCC offers a multistep process to meet the goal of sustainable employment-- assessing and supporting human services needs- housing, food, transportation, and childcare while focusing on job skills training, resume creation, job search, interview and soft skills training, and then making connections with employers who are willing to offer formerly incarcerated people, who are traditionally seen as less marketable, a second chance."

Most returning citizens come to the BRCC from halfway houses, sober houses and at the direction of their parole officer to find employment and have little to no financial resources. ABCD staff reach out to returning citizens days after their release to assess needs and priorities, and connect them to supportive services. In addition to stable employment, some of those needs include housing costs, fines and fees from the Registry of Motor Vehicles and child support, social disconnection and resume gaps. Increased staffing covered by the grant enables ABCD to expand its current BRCC caseload by 80 individuals; expand its capacity for outreach to correctional facilities; and train staff to incorporate the Level of Service/Case Management Inventory risk assessment tool that measure the risk and need factors of late adolescent and adult offenders.

ABCD has established a working partnership with the Massachusetts Department of Corrections, the Middlesex (County) Sheriff's Office, and the Suffolk County Sheriff's Department to provide services to soon-to-bereleased and recently released individuals. This allows BRCC to provide current inmates with assistance to improve their readiness for post-release employment and offers support services navigation for a minimum of six months, or as long as a returning citizen remains engaged, following release from prison.

A nonprofit human services community action organization, ABCD provides low income residents in the Boston and Mystic Valley areas with the tools, support and resources they need to transition from poverty to stability and from stability to success. Each year, we've served more than 100,000 individuals, elders and families through a broad range of innovative initiatives as well as long-established, proven programs and services. For more than 50 years, ABCD has been deeply rooted in every neighborhood and community served, empowering individuals and families and supporting them in their quest to live with dignity and achieve their highest potential.

port it 100 percent."

Another attendee at the meeting said he had talked with numerous residents, and they were unanimous in their support of the store and happy that it would be a locally owned business.

Kelly said a percentage of all revenues from the store would go toward mental health and addiction programs.

In an interview this week, Kelly said the name of the new store would be Charlestown Cannabis. He has a 10-year lease for the business that he calls "a boutique store."

Jack Kelly, 43, is a fourth-generation Charlestown resident of Charlestown. He is the father of a 16-year-old daughter, Amelia. Jack is the son of Johnny Kelly and Betty Kelly, who attended the Aug. 8 meeting. His grandmother, Betty Kelly, resides in Charlestown. He is named after his late grandfather, John Francis Kelly Sr., a United States war veteran.

Kelly is a 1999 graduate of Matignon High School where he was the captain in the school's powerful ice hockey program. He holds a degree in political science from UMass Boston and was a candidate for an at-large seat on the Boston City Council in 2013.

Asked about the outpouring

of support for his dream to open his own business in Charlestown, Kelly said, "I'm grateful for the support of the community. It was touching to be from this commu-

nity and get that type of reception at the meeting. It showed the good spirit of Charlestown, and it feels good."

# Fiesta en la Plaza returns to celebrate Latinx Heritage Month

Fiesta en la Plaza will return to City Hall Plaza this September to offer a diverse lineup of free, festive cultural events as part of the City of Boston's celebration of Latinx Heritage Month, announced Ágora Cultural Architects.

This second edition of Fiesta en la Plaza will showcase the rich diversity of our Latin American communities in Boston. Talented artists from various Latin American countries, who now call Boston home, will share their cultural roots through a variety of music, dance, and Afro-Latin films, explained Elsa Mosquera, co-leader of the event's curator and producer, Ágora Cultural Architects.

"We are happy to welcome Fiesta en la Plaza to City Hall for the second year in a row and to join in celebration with our Latin American communities. Each artist and each event is an opportunity to continue learning about the cultural diversity of our City while having a great time. Estamos listos para bailar y celebrar con todos!" said Kara Elliott-Ortega, Chief of Arts and Culture for the City of Boston.

The Fiesta will begin on Sunday, September 15, featuring Puerto Rican virtuoso cuatrista and singer Fabiola Méndez and her trio, award-winning saxophonist Edmar Colón with Alain Mallet, and the band of creative Colombian artist Manuela Sánchez Goubert. The audience will be able to dance to different rhythms accompanied by the MetaMovements dance group.

Fiesta en la Plaza activities will continue on September 19 at the Civic Pavillion, with film presentations inspired by the Afro-Latin theme and a dialogue between Afro-Latin artists from the City, hosted by cultural journalist Cristela Guerra. # Bento box solutions

Some scholars contend that the word "Bento" comes from a Chinese dialect term, "biandang," meaning convenient. Anyone who has used bento boxes of any shape or size must agree that a purpose-built container for a one-person meal is handy.

#### Leftovers

You may have yet to consider the many problems this concept addresses. We use a stainless steel bento with a silicone-sealed cover and divider for leftovers from restaurant meals. It saves the restaurant the cost of a take-out container and is sustainable, resulting in less trash.

If you have lazy eaters in your household who wouldn't dream of gathering a plate of goodies from the refrigerator for a meal, consider packing items from the table into bento boxes for each person. You could even hand everyone a bento and have them create the second-act meal themselves. Mark the ownership with blue kitchen tape, and a meal will be ready to grab and go for lunch or when their eating schedule is not in sync with yours.

Portion and Nutrition Control The design of bento boxes


makes them a perfect vehicle for portion and nutrition control. Whatever diet or food preference you or your eaters follow, there are bento boxes in sizes and styles to suit every need.

A preset meal can be a great weight control strategy until your body learns the right amount of food to satisfy your hunger. You can pack the meal by calorie count to reduce sugar and highly refined starches, ensure the proper protein portion, or increase your vegetable intake. You can eat the meal straight from the box or transfer it to a dinner plate to help you learn more about portion control.

#### Special Needs

You can use larger boxes for an athlete or person who does physical labor, while small ones are perfect for tiny people. You can also use bento boxes to tempt a person with a waning appetite, undergoing chemotherapy, or recovering from an illness or injury.

Providing food for the sick room is the one time we recommend using disposable bentos. A gift of a variety of small prepared

meals, designed with a specific person's tastes in mind, could relieve the patient and caregivers of a significant task.

Brumotactillophobia is the technical term for a person, often a child, who fears different foods touching one another. A bento box with dividers that keep foods separated is an excellent tool for those who suffer from this mild form of obsessive-compulsive disorder or are on the autism spectrum.

Visual Appeal

show bento box lovers how to design appealing presentations. Some mothers aim to make a packed lunch more attractive to a child or to encourage the child to eat different foods. It is simply a creative outlet for others-making a daily chore more enjoyable.

Variety and visual appeal are also essential to succeed with picky eaters or someone with a failing appetite. Small portions can seem more appealing than a big plateful of food.

If you look at photos of traditional Japanese bento boxes, you'll see a pleasing array of colors and textures. Most contain

starch like rice or noodles, a portion of meat or fish, vegetables, and sometimes a tiny dessert or lovely piece of fruit to round out the meal.

What you might miss seeing in this picture is how balanced and nutritious this dining style can be. A bento box or two might be perfect for serving some meals in your household.

spent valuable taxpayer dollars in the process and since PLAN: East Boston was enacted five months ago, the ZBA has approved eight non-compliant cases. There must be a demonstrated commitment by new and returning ZBA members to enforce Plan: East Boston to undo a decade of harm and build trust with community members."

The Zoning Board Appeals is composed of seven members who are appointed every three years by the Mayor. The board inspects and reviews buildings for zoning compliance and has administrative oversight of the Inspectional Services Department. Since 2013, the Zoning Board of Appeals has

approved 789 cases of the 980 (80.5%) that have gone through the board. In East Boston, since 2019, the ZBA has approved 422 cases of the 553 (76.3%) that have gone through the board.

During the hearing, Coletta Zapata went on the record to state her hesitancy to vote for ZBA appointees that did not come before the body and answer questions on the record about upholding the current zoning regulations. Additionally, Coletta Zapata called for a full-time ZBA member from East Boston given that the neighborhood has had the most variances in recent years. The Councilor questioned new mem-

bers on how they would take into consideration financial hardships for developers when the proposal does not benefit the neighborhood.

On April 29th, 2024 during a budget hearing in the FY25 budget review, Councilor Coletta Zapata advocated for communication between the ZBA and Inspectional Services Department to ensure members were briefed on the zoning changes. As the department charged with administrative support to the ZBA, Commissioner Del Rio committed to working with ZBA members to have trainings that would fully educate ZBA members on the approved zoning reform for East Boston.

Committee hearings are noticed under the discretion of the Committee Chair and must comply with the Open Meeting Law which states that a meeting must be noticed 48 hours in advance. Residents are encouraged to reach out to Councilor Coletta Zapata and District 8 Councilor Sharon Durkan, Chair of the Committee on Planning, Development, and Transportation, with any additional public comments.

Lot Lab is a continuation of the Triennial's collaboration with the National Park Service and is also part of the City of Boston's "Un-monument | Re-monument | De-Monument: Transforming Boston," a program of temporary artworks, public talks, and engagement activities supported by the Mellon Foundation's Monument Project. This year's theme, Presence, guides the three artists as they explore cultural symbols and hidden histories in Charlestown.

This year's Lot Lab artists are local artist Matthew Okazaki who created TORII, a series of architectural sculptures referencing a nearby symbolic Japanese Torii Gate at the historic Marine Barracks, which rectifies its loss of meaning and cultural heritage. Ifé Franklin, also local to Boston, designed The Resurrection of Mark, Phillis, & Phebe, a floating indigo cocoon sculpture that offers a place of rest for the spirits of three enslaved ancestors. Her work quilts together traditional African adire textiles

and cosmology to tell a tale of Black diasporic resistance, honoring Mark, Phillis, and Phebe, who lived in colonial Charlestown and died for their freedom after rebelling against their enslaver. Nationally acclaimed artist Hugh Hayden is recontextualizing Gulf Stream-a surreal, hybrid boat sculpture first exhibited at Brooklyn Bridge Park and on loan courtesy of Lisson Gallery- connecting local histories like that of the enslaved labor that harvested timbers for the hull of USS Constitution to global histories of trade, migration, and labor.
